### APPLICATION

*Directions for use:*

Always test on an inconspicuous area first. May dull some painted surfaces. Not recommended for use on non-colorfast materials, or woodwork.

*Directions for hard & soft surfaces such as signs, plexiglass & vinyl:*

1. Thoroughly spray area damaged by graffiti, and wait 1-2 minutes.
2. Wipe off with a clean cloth or towel.
3. Repeat if necessary.

*Directions for porous surfaces such as concrete & brick:*

1. Thoroughly spray area damaged by graffiti, and wait 3-5 minutes.
2. Use a brush to agitate and loosen graffiti.
3. Hose off with water, or use pressure washer, and wipe with a clean towel.
4. Repeat if necessary.
